STAMP

WORK ELIGIBLE

Open to all artists working in the Pastel Medium. NO OIL PASTELS. Work may be traditional or non-objective and must not have been previously exhibited in any CPS show. **All work must be predominantly (80%) executed in soft pastels.** Neutral mats please. Entries must be original. Work done under the guidance of an instructor is not eligible. Painting must be identical to accepted slide. No paintings over two years old. Work to be hung must not exceed 48" wide by 60" high, including frame. Work must be firmly framed, under glass or Plexi Glass with sturdy screw eyes and strong wire, ready to hang. **No saw-tooth hangers.** West Hartford Art League and CPS will not be responsible for loss or damage of shipped entries using glass.

PROCEDURE FOR ENTRY

Each artist may submit up to three slide or digital entries. **Slide entries** must be a 35mm color slide standard 2" x 2" mount. No photographs. Indicate top and front. Print your name, address, title and size (including frame, HxW) of painting on slide. **Digital entries:** File format must be JPG. CD must contain only the images intended for submission. Individual file size should be no larger than 5MB. Resolution should be 300 dpi. Crop image to exclude mats or frames. **Files should be saved as: last name of artist-title.jpg.** For example: DeSomma-NoFishToday.jpg (abbreviate title if very lengthy). Neatly print on CD with permanent marker: name, title, HxW, email address. Email submissions cannot be accepted. Improperly marked CDs will be disqualified. CDs will not be returned. Make checks payable to "CPS 2008 Renaissance Show" and send **First Class Mail** with slide(s) or CD, completed entry form and #10 SASE to: Rita Caldwell, 18 Tandem Drive, Bethany, CT 06524

FEE STRUCTURE

Members: \$25 for 1 or 2 slide/digital images, \$30 for 3 slide/digital images. **2008 dues must be paid.** Non-members: \$30 for 1 slide/digital image, \$40 for 2 slide/digital images, and \$45 for 3 slide/digital images. Entries from outside U.S. must be paid with money order in U.S. currency. **Incomplete entries will be declined and entry fee will not be refunded.**

SALES

A 30% contribution will be taken on all work sold. If work is listed NFS, the value must be given. NO POR.

REMOVAL

Exhibited work may be picked up after the demo on **Sunday, October 26, 2008 from 3-4 PM.** All work not called for will be stored at the shipping center with a minimum \$20 pick-up and storage fee.

All work will receive careful handling by competent staff; however, The Saltbox/ Clubhouse Galleries and the Connecticut Pastel Society, or anyone connected with this exhibition cannot be held responsible for the loss or damage to any work of art submitted for exhibition consideration. All work submitted is subject to this condition, which must be accepted by all participants. Signature on entry form constitutes agreement. We recommend artists carry their own insurance.
